**ARCHIVES:** (Dianne Kauffman) Dianne entertained us with items from the minutes of December 10, 1997 and January 21, 1998 WAB meetings. Highlights:

- The new stair glide leading to the Manor House Auditorium (now named the MH Reception Room) was funded by the Women’s Auxiliary Board (now the AB).
- A new Web site was launched
- Strategic plans for 1998 included completing the Wolle Building and remodeling the Carriage House.

**FINANCE:** (Kathy DeBarr) The AB has given \$2525.72 (end-of-year balance) to the SHHG operating fund.

**MEMBERSHIP:** (Cindy Bruning) The new membership application is available. We have one Provisional so far. The committee will be meeting soon. Cindy Bruning, Char Bolek, and Elise Bennett will meet to discuss membership recruitment and other AB topics this Friday, Feb. 26.

**NOMINATING:** (Hugh West) Emails were sent out to this year's officers asking if they would be willing to serve as officers next year. Per our bylaws, an officer may serve up to 2 consecutive years in the same position. The following positions have been held for 2 years and must be filled: Recording Secretary, Corresponding Secretary, Assistant Secretary, and Treasurer. The proposed slate of officers must be prepared by the March General Meeting.

**OHIO MART:** (Darby Ashelman):

- The final financial results for Ohio Mart 2020 were presented by Treasurer Joann Wallace. Revenue totaled \$13,526.
- Mary Ann Stuyvesant, 2020 Chair of Patrons, thanked all for their support and donations last year. She performed the drawing of one of the 23 names that contributed to Patrons at the Gold level. The drawing was for ten 2021 Ohio Mart tickets and for Patron parking through 2023. It was won by "Anonymous" (who is known to Mary Ann).
- The dates for the 2021 Ohio Mart are October 7-10. In accordance with the standard set by Stan Hywet for annual events, such as Gala, The Father's Day Car Show, and Ohio Mart, this will be the 54<sup>th</sup> Ohio Mart, since we did not hold the 54<sup>th</sup> last year.
- We have received 80 applications to-date on Zapplication, 5 of whom are new applicants. Some of last year's accepted exhibitors have taken advantage of the \$10 coupon we offered to them to reduce their 2021 application fee. In January we received enough revenue to pay our \$1100 fee to Zapplication and still receive a check for \$325.24. So, we already have revenue for 2021.

- A&B Tents will not be giving a 10% discount for early booking this year. We are not aware of any price increases.
- Gretchen Gibson announced that Vintage Finds is taking donations. Please contact Gretchen or Michelle Pringle to coordinate donations.
